### Aim

To promote lifestyle practices, amongst children, educators and families and visitors that will protect them from the harmful skin damage that results from cumulative exposure to the sun.

## **Implementation**

- This policy is for implementation from 1 August until 30 April and when the ultraviolet (UV) radiation is 3 and above at other times. A combination of sun protection measures are considered when planning outdoors activities such as excursions and water based activities. When the UV radiation is below 3, children, educators and staff are not required to wear sun protection. Safe sun exposure is important for the production of vitamin D for bone growth and development.
- 2. Parents are requested to send their child with a hat that shades the face, back of the neck and ears (such as a broad brimmed or legionnaires style hat at least 6 cm for children and 7.5cm for adults and with a deep crown, baseball caps are not acceptable) and appropriate clothing. Recommended clothing is a shirt/ dress with elbow length sleeves and a collar and longer style shorts and dresses. If possible, parents can provide close fitting wraparound sunglasses that meet AS/NZS 1067.1:2016, lens category 2, 3 or 4.
- 3. Parents of children in Rooms 2 and 3 are requested to apply sunscreen to their child on arrival at the Centre if the UV is 3 or above, and to notify staff of the time of application.

- 4. The Centre will purchase a reputable brand of SPF 30+ broad spectrum, water resistant sun screen (suitable for use on young children) for use by children and staff while they are at the centre
- 5. Parents providing their child with their own sunscreen from home need to provide a pharmacist issued sticker on individual sunscreen bottle, including child's name.
- 6. During the months 1<sup>st</sup> August to 30<sup>th</sup> April educators will supervise application of sunscreen to children 20 minutes before each outside play session and regularly reapply (around two hourly) if outside for an extended period of play or during water activities when the UV rating at the Centre reaches 3 and above.
- 7. Educators will encourage children to wear hats when outside and will ensure that children wear hats when outdoors 1<sup>st</sup> August to 30<sup>th</sup> April and whenever the UV is 3 and above at other times. Children not wearing hats or appropriate clothing will remain in fully sun-protected areas when outdoors.
- 8. Exposure to the sun during harmful hours, during peak UV times from 1<sup>st</sup> August to 30<sup>th</sup> April, and when the UV is 3 and above outside these times, will be minimised by setting up outdoor activities in shaded areas or scheduling outside these times as much as possible.
- 9. For Work Health and Safety and role modelling, educators, students and volunteers (including parents and visitors) are required to apply sunscreen, wear appropriate hats, clothes and seek shade when outdoors when the UV is 3 and above. Families and visitors are encouraged to use a combination of sun protection measures when participating in or attending outdoor events.
- 10. The Centre will incorporate age appropriate sun and skin protection awareness into the program.
- 11. The Centre will regularly reinforce and promote SunSmart Behaviour to the whole community (via newsletters, brochures and displayed information) and all families and staff will be informed of the policy.
- 12. The Board and the Parent Advisory Group will aim to provide and maintain shelter and trees to ensure that there are adequate shady areas in the outside play area.
- 13. To assist with the implementation of this policy educators will use the Centre's UV meters to monitor the UV level at the Centre each day during the peak UV period 1<sup>st</sup> August to 30<sup>th</sup> April and at other times when the daily UV weather alert at <a href="www.bom.gov.au/sa/uv">www.bom.gov.au/sa/uv</a> is 3 and above.
- 14. Educators are encouraged to access the SunSmart daily UV alert via: www.bom.gov.au/sa/uv
- 15. The Sunsense Policy is reviewed regularly (at least every 3 years) to ensure the policy remains current and relevant.
- 16. The Sunsense Policy is applicable to all centre activities both on site and off site (eg excursions).

#### For children in Room 1 -

- 17. Educators in Room One will discuss with each family, their wishes on outdoor play and the use of sunscreen for immobile and mobile babies aged 6-12 months. Children in this age group who are not having sunscreen applied will either be kept inside or only taken outside when they can be in total shade i.e. at least 2 metres from the nearest source of sunlight.
- 18. All babies under 12 months are to be kept out of the direct sun as much as possible during the daily sun protection times (i.e. when the UV is 3 and above).
- 19. All babies should be protected by using shade, sun-protective clothing, wraps and hats. If direct sun can't be avoided when the UV is 3 and above, sunscreen should only be applied to small areas of exposed skin not protected by clothing or hats on babies 6 months and older.
- 20. When the UV is below 3, sun protection is generally not required and a small amount of direct UV exposure is considered safe and healthy for infants. However, if spending longer periods of time outdoors during low UV periods, it is recommended that skin be protected from UV exposure with clothing and shade when available.
- 21. Children under 12 months will have their hands and face wiped after outdoor play to remove sunscreen. This may coincide with preparing children for lunch or snacks.

#### For older children

22. Children from Room 2 and 3 may have some outside play between 10.00am and 3.00pm (peak UV radiation times) during 1<sup>st</sup> August and 30<sup>th</sup> April. There may be times when the group dynamics and activity levels of children warrants outside play at this time. This will occur only after consultation with individual parents. Outside play will only be in fully shaded areas and will be closely supervised by educators to ensure children follow all sun-safe procedures, including the wearing of sun protective clothing, hats and sunscreen reapplication every 2 hours.
