Report from the Chancellor

The Chancellor reported on recent events she attended including:

- the University's Golden Jubilee, 150th Gala Ball, Julia Gillard Lecture, Celebration of Learning and Teaching, and Distinguished Alumni Awards; and
- the graduation ceremony for Medicine and the valedictory ceremony for Veterinary Medicine.

The Chancellor congratulated the University's recent graduates who received the Rhodes Scholarship and the John Monash Scholarships.

 - the Sewell Myers Research Bequest;
 - the John Mortlock Medical Bequest;
 - the Guli Magarey Prize for Singing;
