Roof Access Details

- Right of Access Permit is only for visual inspection and a different permit is required before commencing any work on the roof.
- Handrails and parapets are not a fall arrest system unless part of a submitted SWMS.
- If using a harness attached to an anchor point/static line all workers must have current Working at Heights training and anchor points/static lines must have been certified in the last 12 months.
- If accessing roof externally a lock out/tag out procedure has been implemented for Fume Cupboards

There is no internal access to external roof.

There is an external ladder on the western side of the building to access roof.
