What is the project about?

Why am I being invited to participate?

You are invited to participate in this study because of your valuable role as a healthcare provider serving women from migrant and refugee backgrounds, with a specialization in sexual health. Your expertise and experiences are essential in contributing to our understanding of the sexual well-being and function of this specific population. Your insights will greatly inform the research and potentially lead to improvements in healthcare practices and support tailored to the unique needs of migrant and refugee women in Adelaide.

What am I being invited to do?

You are invited to participate in a research study that entails completing the questionnaire and taking part into the interview. The questionnaire is focused on gathering demographic information. This includes



details about your education, occupation, residential address, ethnicity, language, religion, country of origin, type, and length of residency, and etc. During the interview, you will have the opportunity to share your thoughts and experiences related to sexual health and any challenges faced by migrant and refugee women. We are particularly interested in gaining insights into whether migrant and refugee women have specific needs and concerns that may not be adequately addressed by existing Australian services.

Your input in both the questionnaire and the interview is highly valuable and will contribute to our efforts to enhance the understanding of sexual well-being and healthcare needs among this population. Your participation will potentially lead to improvements in healthcare practices and support tailored to the unique requirements of migrant and refugee women in Adelaide.

How much time will my involvement in the project take?

The interview will take about 60 minutes to complete.

Are there any risks associated with participating in this project?

Participating in this research project carries minimal risks. The primary objective is to collect your valuable experiences and insights concerning the sexual well-being and function of migrant and refugee women to whom you provide services. While there are no specific risks or concerns associated with participation, it is possible that you may need to share specific information or experiences related to your services.

What are the potential benefits of the research project?

While participants may not directly benefit, the study's outcomes will inform subsequent research directions, thereby providing valuable insights and guidance regarding women's sexual health. This contribution will aid in the advancement of programs and scholarly inquiries in this domain. As a gesture of gratitude, participants will receive a reimbursement of \$100.

Can I withdraw from the project?

Your participation in both the questionnaire and the interview is voluntary, and you have the right to withdraw from the study at any time without any obligation. Importantly, this withdrawal will have no impact on your current or future medical care or any other services they may receive. In the event of withdrawal, all collected data up to that point will be promptly discarded and will not be used for any analysis or included in the final study results. Moreover, no personal information or identifiable data will be stored or retained.

What will happen to my information?

The information gathered will be treated with the utmost sensitivity to uphold privacy and confidentiality. Your name and any personally identifiable information will be safeguarded, using pseudonyms or codes to protect your identity. Interview transcripts and questionnaires undergo a thorough de-identification process, replacing real names with pseudonyms.



To ensure participant anonymity, specific details like names and locations are systematically removed. Following data collection, it will be securely stored in a password-protected cloud system and encrypted platforms at the university of Adelaide. No identifiable information will be used in publications, reports, or academic theses.

Upon request, participants can receive a summary of the results, maintaining transparency and accessibility while preserving confidentiality. Overall, the information will be managed responsibly, adhering to ethical guidelines and regulations. Your information will only be used as outlined in this participant information sheet and will be disclosed only in accordance with the provided consent, unless required by law.
