# The University of Adelaide Student Services and Amenities Fee (SSAF) 2023 Allocation Report

The Higher Education Support (Student Services, Amenities, Representation and Advocacy) Guidelines 2022 require higher education providers to provide a publicly available report on student services and amenities fee (SSAF) allocations and actual expenditure for the year as part of their annual reporting and in the form approved by the Minister. This SSAF Allocation Report is the form approved by the Minister.

Additional reporting was introduced to allow for greater transparency and consistency in SSAF allocations and expenditure.

Please note, the information provided in this SSAF Allocation Report does **not** require auditing by a financial accountant. The SSAF <u>expenditure reporting remains unchanged</u>, more information can be found in the <u>Financial Statements Guidelines</u> for Table A and B providers, and in the <u>Financial</u>

### SSAF Consultation and Achievements

In allocating the SSAF for 2023, the University has undertaken a two-phase consultation process with students. The first phase involved surveying all students regarding their priorities for allocation of the SSAF.

The second phase involved consultation with democratically elected student representatives as required under the Student Services, Amenities, Representation and Advocacy Guidelines. This consultation was carried out through the SSAF Consultative Committee, which was established in 2011. This committee comprised student representatives from the Adelaide University Union (YouX), Student Representative Council, international and postgraduate student representatives as well as Adelaide University Sport and Fitness (AUSF).

YouX, AUSF and the University were asked to submit SSAF funding requests on behalf of all groups to the committee. They were asked to take feedback from the student survey into account when forming these submissions. The Committee then made recommendations to the University on the allocation of SSAF funding for 2023.

A snapshot of successful 2023 SSAF funded activities include:

#### Health, Welfare & Wellbeing

- Student Health and Wellbeing
  - o The implementation of the Student Mental Health and Wellbeing Strategy has supported a range of activities and engagements including:
    - Wellbeing Champions Network.
    - o Safe Sex, No regrets campaign.
    - o Connect HIV self-testing vending machines.
    - Student-led social media engagement throughout the year through Instagram and wellbeing blogs.
    - Health Promotion campaigns and events in line with the student life cycle.
    - Multiple Mental Health First aid courses run throughout the year for students and staff.
    - o Wellbeing Warriors student volunteer program.
  - Wellbeing Project Officer
  - Wellbeing Project Support Officer
- Counselling Support
  - o Specialist Sexual Assault and Sexual Harassment Counsellor.
  - After hours crisis line dedicated to University of Adelaide students who experience a mental health crisis.
  - Weekly counselling outreach support to Roseworthy campus.
  - Specialist Aboriginal and Torres Strait Islander counsellor.
  - Delivery of MATE bystander awareness training to student groups.

  - o Delivery of dedicated wellbeing, stress relief and exam support events and activities

  - Member engagement strategy to provide more sport and recreation opportunities to more students across all campuses.
- On campus events such as O Week, Sports Week and the delivery of social sport Monday Thursday.
- Facilitating the Elite Athlete Program and pathway to Performance grants, providing scholarships to students. Implementation of UoA University Basketball League team.
- Facilitating student involvement in intervarsity competitions across South Australia, nationally and internationally.
- Supporting infrastructure and facilities used by AU Sport and Fitness clubs
